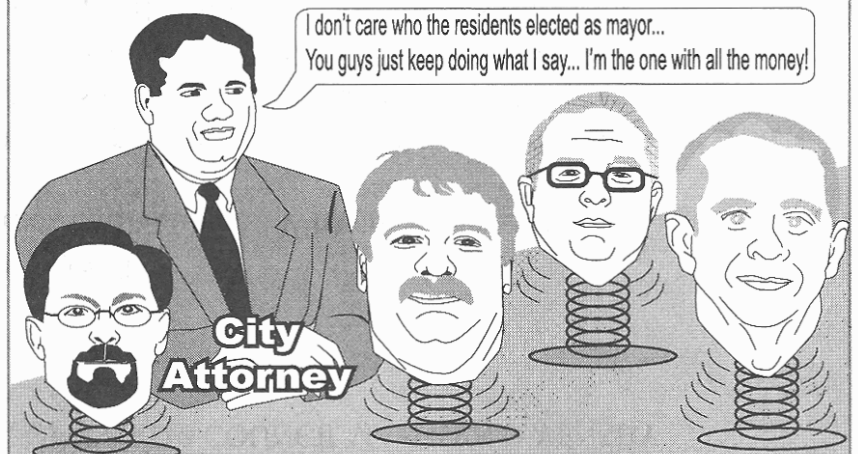
Vote NO on Prop A.
